
Alderman Sandra Garrett made the motion to pay invoices, seconded by Alderman Carol Eagle and passed unanimously.

Fire Department-Report Included

- Chief Danny Akines was absent

Park Commission-Report Included

- Park Commissioner Diann Smith stated that Coker electric would be putting lights on the back side of the walking trail.
- She also informed that the entire park would be rented this coming Saturday for an employee appreciation dinner for a company working in town. (Buckner Industrial Rigging)

Planning Commission

- Planning Commissioner Jim Ferguson stated that there was no meeting last month

- Police Chief Steve McFatrige stated that he had spoken to Mr. Jimmy Jackson and he informed that Insley Towing was no longer interested in the potential agreement discussed.

Police Department – Report Included.

- Police Chief Steve McFatrige stated that they are aggressively working on leads in the attempted robbery case at Relyance Bank night deposit. He also advised that Redfield PD is always available for assistance when making nightly deposits.

Animal Control

- Jud Ashcraft informed that they are working to get a Great Pyrenees retrieved from the highway to a Great Pyrenees rescue shelter and have a few other potential adoptions later this week.
- James Smith stated that the relationship with Animal Control and Redfield Friends of the Animals has grown and they are working together to find homes for all the dogs brought into the shelter.

Street Department-Report Included

- Street Superintendent James Smith stated that he expects bids for the Sidewalk project to go out in late November or early December and that construction would not be until spring 2017.
- He also asked the council to consider the purchase of a new street department truck and a sweeper attachment for the tractor. Mr. Smith and the council discussed prices and budget scenarios, but no action was taken.

Water Department – Report Included.

- Water Superintendent Chris Liles reported that a new boat was purchased for the sewer pond to replace the old one that had a hole in it.
- He also stated that he had met with Republics Services, and has received a proposal from them and Waste Management. He stated that he would like to take from both proposals the specific needs that the City wants and put the service out for bid.
- Counselor Margaret Dobson stated that the Century Link property is now owned by the Redfield Water Department.
- Alderman Tony Lawhon made a motion to accept the bid from Liles Contracting to mow and bush hog water easements which was seconded by Alderman Sandra Garrett and passed unanimously.

- Dan McDonald from Family Church spoke to the council about their plans to start a Community Supported Food Pantry.
- Dr. Tracy Phillips addressed the council about his desire to place a family medicine clinic where the old police department building use to be. He stated that he is working with Mrs. Pat Everett about leasing the property and placing a modular building there. Planning Commissioner Jim Ferguson informed him that it was zoned properly for the building and business, so all he would need from the City is a building permit. Dr. Phillips said that he hoped to get everything going by the end of the month.
- Alderman Sandra Garrett brought to the attention of the Council the recent availability of property surrounding City Hall, and expressed that it may be something that the City inquired about purchasing. After a short discussion with Council, Mayor Harmon Carter said he would speak to the owners of the properties about their willingness to sale.
- Alderman Carol Eagle stated that the Halloween Carnival was a huge success and wanted to thank everyone involved for doing such a great job.
- Council decided to have a Budget Meeting on November 29th at 7 pm.
- James Weldon from Entergy informed that Family Church had the complete support of Entergy and all of White Bluff in the Community Food Pantry Project.

October 4, 2016

Mayor Harmon Carter called the meeting to order at 7:00 pm.

Chris Liles led the group in prayer.

Mayor Carter led the group in the Pledge of Allegiance.

Roll Call: Aldermen Darrell Hedden, Carol Eagle, Allison Beasley, and Tony Lawhon were present. Aldermen Sandra Garrett and Jeremy Williams were absent.

Audience attendees included Chris Liles, James and Diann Smith, Steve McFatridge, Danny Akines, Elizabeth Milam, Bobby Gilliam, Jimmy Jackson, Jim Ferguson, Donna Oates, Linda Banks, Bobby and Allison Turner, & Jud Ashcraft.

Alderman Tony Lawhon made the motion to accept the September City Council Minutes, which was seconded by Alderman Carol Eagle and passed unanimously.

Alderman Carol Eagle made the motion to accept the September Financial Report, which was seconded by Alderman Allison Beasley and passed unanimously.

Alderman Tony Lawhon made a motion to move new business to the top of the agenda which was seconded by Alderman Allison Beasley and passed unanimously.

New Business

- Mr. Jimmy Jackson spoke to the council about the possibility of renting his property on Sheridan Rd to Insley's Towing. The business would consist of a portable building and no more than 2 wreckers. Planning Commissioner Jim Ferguson told the council since the current ordinance does not specifically mention portable buildings in any manner, he advised Mr. Jackson to speak with City Council before proceeding. After further conversation with Mr. Jackson, the Council asked if he could come back next month with more specifics about the building that will be placed on

the property and possibly get Mr. Insley to attend also. Mr. Jackson agreed and no other action was taken.

- Mrs. Linda Banks addressed the council about the need to vote for the county wide Library millage. She stated that if the millage passed, the Redfield Library would add 2,000 sq. ft. to the existing building, which would become a new community room & computer lab. Along with the new addition, the Library would also receive 12-18 new computers. Mrs. Banks stressed that the millage increase would only be ¼ mil, would last around 3 years, and would equal to about \$4-\$5 per year, per household.
- Bobby Turner informed the council that the Redfield Masons would be handling the Bridge lighting this year. He stated that the lighting would take place on Dec 3rd and they hope to also light a tree near the bridge and have a parade before the lighting ceremony.

COMMITTEE REPORTS – all Committee Reports will be included in the minutes

Fire Department-Report Included

- Chief Danny Akines reported that they went on 20 runs last month.
- He also thanked James Smith and the Street Department for their help in cleaning and repairs done to Station 1.
- Chief Akines stated that he would be applying for Federal Fire Grant in October.

Park Commission-Report Included

- Park Commissioner Diann Smith stated that at the last meeting, they discussed putting lights around the walking trail at the park. Entergy's quote was too high and they are exploring others that could provide the service.
- She informed that there would be no meeting in October.
- She also informed the Council that she had been voted to serve on the Arkansas Recreation and Parks Board.

Planning Commission

- Planning Commissioner Jim Ferguson re addressed Mr. Jackson's proposal for a portable building by stating that it could be a good deal for the city if a permit was submitted with a time limit. A sunset clause.

Police Department – Report Included.

- Police Chief Steve McFatridge stated he hired Jacob Sims on September 16th for the open officer position.
- He asked the council to approve the purchase of 2 new Tasers for \$1,042 each which would be taken out of PD Savings. Alderman Carol Eagle made the motion to purchase the Tasers which was seconded by Alderman Tony Lawhon and passed unanimously.

Animal Control

- Jud Ashcraft informed that Redfield Friends of the Animals adopted 2 dogs out and will be transporting 2 more to Maine this week.

Street Department-Report Included

- Street Superintendent James Smith reported that the easements for the sidewalk grant have been filed. He does not expect construction to start this year, but City Engineer Vernon Williams hopes to get bid package out soon.
- He also stated that the city received a bill that will be for the sidewalk grant and asked who should pay for it since it is not technically a street issue. Alderman Darrell Hedden made the motion that the bill be paid out of General Fund which was seconded by Alderman Carol Eagle and passed unanimously.

Water Department – Report Included.

- Water Superintendent Chris Liles reported that the capacity study showed that it would be possible to add 300 homes to the current system.
- He also recommended that the yearly rate increase continue for 2017. Water rates will increase in January 2017 and sewer rates will increase in July 2017.
- He stated that sanitation is going up 11¢ per customer. Mr. Liles and Street Superintendent James Smith both stated their displeasure with Waste Management and would like to research other waste services in the area.

Old Business

- Counselor Margaret Dobson asked for the Council's approval to take the lot from Century Link for the Water Department. Alderman Darrell Hedden made the motion which was seconded by Alderman Tony Lawhon and passed unanimously.
- Counselor Margaret Dobson stated that Chief Steve McFatrige was unaware of the Solicitation Ordinance that was passed last month until the night of the meeting. He had many questions and concerns. He has suggested some changes and provided some example ordinances that he feels would better suit the city. She stated that after she researches it more, we may need to amend the recently passed ordinance.
- She also stated that she feels like the current Sign Ordinance needs to be updated and needs input from council on how to address the issues.

New Business

- Counselor Margaret Dobson Read Resolution 2016-04. Alderman Darrell Hedden made a motion to accept the resolution which was seconded by Alderman Carol Eagle and passed unanimously.


Alderman Carol Eagle made the motion to pay invoices, seconded by Alderman Darrell Hedden and passed unanimously.

Alderman Tony Lawhon made the motion to adjourn, seconded by Alderman Darrell Hedden and passed unanimously.

- He said he would talk to the county about mosquito spraying after Alderman Sandra Garrett voiced concerns that the spray could be killing other pollinating insects.

Water Department – Report Included.

Fire Department-Report Included

- No report

Park Commission-Report Included

- Park Commissioner Diann Smith stated that Recorder/Treasurer Dane Fults submitted the final RAA bills and she will review them.

Planning Commission

- Planning Commissioner Jim Ferguson stated that Jane Stout had submitted a sketch plat for the expansion of the Park Lakes subdivision. He said he would call a Planning Commission meeting on the 4th Thursday in July.

Police Department – Report Included.

- Police Chief Steve McFatridge stated that the Chevrolet Impala would be stripped at a cost of \$705
- He also asked that the ordinance concerning fireworks be look at and potentially amended.

Animal Control

- Jud Ashcraft reported that they handled 10 dogs.
- James Smith stated that he had updated the prices on the "return to owner" forms.
- He also stated that he will be visiting with a program called Paws for Prisoners.

Street Department-Report Included

- Street Superintendent James Smith reported that they had issues with Arkansas One Call, thus they were not able to clean ditches on River Road since the lines were not marked.
- He stated that expansions joints on the James St Bridge would be fixed on the 11th & 12th.
- He gave the council stats from a Pavement Management Program and advised of some potential road cost the city will be facing.
- Mr. Smith also present a bid to chip and seal the Park Lake Roads. Mayor Carter assured council that the bid was not necessary because the County would be coming to do the work. No action was taken.
- He also reported that water was making its way under the road bed on Michael. The City Engineer projected a price of \$7,500 to repair. Mr. Smith said Larry Reynolds with Southeast Arkansas Regional Planning commission was currently looking for a grant.

Water Department – Report Included.

- Water Superintendent Chris Liles reported that developers in the area are wanting to add 320 new residents to the water/sewer system. He stated that the engineers did a low estimate on the last sewer study and would like approval to get the sewer system reanalyzed to determine current sewer capacities. Alderman Sandra Garrett made a motion to reanalyze the sewer capacity which was seconded by Alderman Jeremy Williams and passed unanimously.
- Mr. Liles stated that J & S Home Builders need to know if there is sewer capacity for 3 lots on Huck Finn. He said that an engineering study, costing approximately \$500, would need to be done at the current pump
